RULE SUMMARY: The amendment to OAR 165-005-0170 adopts current revisions to the Oregon Motor Registration Manual. Revisions include changing how information is presented, clarifying the Secretary of State Elections Division information processing, and technical fixes necessary to conform to the new ORVIS (formerly Oregon Votes) centralized voter registration system.

## **RUIFTEXT:**

The Secretary of State designates the Oregon Motor Voter Registration Manual as the procedures to be used for voter registration and voter updates of qualified individuals from certain DMV interactions.
