The defendant having been charged with the crime(s) of CRIMINAL MISCHIEF IN THE SECOND DEGREE herein, and the District Attorney having determined that it is appropriate to propose a Diversion Agreement pursuant to ORS 135.881 et. seq., and the defendant having agreed to the terms of that agreement, now, therefore, the parties do acknowledge and agree as follows:

1. MANDATORY TERMS

A. Duration of the Diversion Period

The diversion period shall be 180 days from and after the date of this agreement. The termination date of the agreement shall be as indicated on the last page of this agreement.

B. Waiver of Speedy Trial.

Defendant has been fully advised of the right to a speedy trial in this matter. Defendant freely, knowingly and voluntarily waives that right during the period of diversion.

C. No Law Violations.

During the period of diversion the Defendant shall violate no federal, state or municipal law or ordinance, minor traffic violations accepted.

D. Admission of Guilt, Waiver of Jury and Stipulation.

Defendant hereby acknowledges that defendant is guilty of the crime(s) charged in this matter. If this matter should ever come to trial, defendant hereby irrevocably waives trial by jury and agrees that trial may be had by the Court alone. Defendant hereby stipulates that in any such trial the State of Oregon can prove each and every element of

the crime(s) charged beyond a reasonable doubt and to a moral certainty and that this stipulation may be received as evidence at trial.

E. Release Agreement.

Defendant shall forthwith contact the Trial Court Administrator's office to execute any requested new release agreements. During the period of diversion all of the terms of Defendant's release agreement shall be in full force and effect. It is Defendant's responsibility to comply with all terms of the release agreement including advising the Trial Court Administrator's Office of any changes in Defendant's address.

F. Verification of Compliance

Defendant understands that it is the sole responsibility of Defendant to complete all of the terms of this agreement and to submit adequate proof of such completion to the District Attorney's Office in a timely manner. The District Attorney may, but is not required to, independently verify completion of any term. If Defendant fails to provide the District Attorney with adequate proof of successful completion, the District Attorney will be justified in revoking this agreement pursuant to paragraph 1G below notwithstanding the fact that Defendant may have actually successfully completed the term in question.

G. Revocation of Agreement

The District Attorney has the sole responsibility to determine if Defendant has complied with this agreement. If the District Attorney finds that the agreement has not been complied with, the agreement shall be revoked and the matter scheduled for trial. The agreement is revoked when the District Attorney files a NOTICE OF REVOCATION OF DIVERSION AGREEMENT with the Court and mails copies thereof to Defendant at the last address provided to the Polk County District Attorney's Office and to Defendant's attorney.

H. Review of Revocation.

If the agreement is revoked, the Defendant may request that another prosecutor in the District Attorney's Office review the matter to determine if that action was appropriate. This request must be in writing, signed by Defendant or Defendant's attorney, and received by the District Attorney not later than 30 days after the NOTICE OF REVOCATION OF DIVERSION AGREEMENT is filed.

I. Completion of Agreement.

If Defendant complies with all of the terms of this agreement, this matter shall be dismissed with prejudice. The District Attorney shall have thirty days after the termination date of this agreement to determine whether Defendant has complied with all of the terms of this agreement. 


